Our township has a task of compiling a list of resources available to the township during times of emergencies and disasters. We ask you to please take some time and review the following forms. Please mark all that you would be willing and able to do for the township. Again, we would only call upon your services during a major emergency in the township.

Enclosed with this is a Notification to the township of someone who may need specific or special help during an emergency. This notification will be kept confidential and at the township office. Please read the notification and mark all that apply so the township can make arrangements to take care of you during an emergency. This form is completely voluntary and up to you to complete. Please keep in mind that the township can only respond to those needs that we are aware of.

If you wish to be part of the Township Alert Roster, please fill out the notification form. The Township Alert Roster will be used in preparation, during response and in recovery of emergency situations or disasters. The township will provide updates on disasters, how to prepare for an impending disaster and recovery efforts after a disaster. This information will **only** be used for official Township business and **will not** be given out to any other party.

The Supervisors of Wheatfield Township wish to take this time and thank you, our residents. Our township has seen emergencies and disasters and unfortunately they will continue to happen. The Township is extremely proud and impressed with the way our community pulls together and helps each other in the time of need.
